>>> Dir. Plouck Provides Update on SPMI Health Homes Statewide Launch

The development of Health Homes is a key component of Ohio's health transformation efforts. Ohio service providers and stakeholder associations have been instrumental in ensuring the effective implementation of Health Homes for individuals with serious and persistent mental illnesses (SPMI). As we move forward with the plan to make health homes a reality statewide, we have become aware of several components of the process that will not line up with a July 1, 2013, launch date. For this reason, the Phase II implementation will be shifted to Oct. 1, 2013. Please read the [memo](#) for more information.
